## **Aircopy Privacy Policy**

Aircopy "the App" provides Al based content genreator for your Products "the Service" to merchants who use Shopify to power their stores. This Privacy Policy describes how personal information is collected, used, and shared when you install or use the App in connection with your Shopify-supported store.

## Personal Information the App Collects

When you install the App, we are automatically able to access certain types of information from your Shopify account: We use Shopify API to fetch all your products and update your products through the App.

Additionally, we collect the following type of personal information from you once you installed the App: The URL of the store and email address registered to your account. Information about you and others who may access the App on behalf of your store, such as your name, url, email address.

We collect personal information directly from the relevant individual, through your Shopify account or using the following technologies: "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps. "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

## How Do We Use Your Personal Information?

We use the personal information we collect from you and your customers in order to provide the Service and to operate the App. Additionally, we use this personal information to: Communicate with you; Optimize or improve the App; and Provide you with information or advertising relating to our products or services. We use your personal information on retargeted advertising on Facebook Ads, Google Ads. We use your personal information on Woopra to analyze customer journey for our product improvements.

## **Sharing Your Personal Information**

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.
